2024 WINTER STORMS







Happy New Year! With the end of 2023 and the beginning of the new year we're now seeing a steady march of El Nino, Polar Vortex's, Bomb Cyclones storms heading across the country and ending up in New England. With the last few years being quiet, we might have anticipated 2024 could be a change from the quiet winters of the not-too-distant past. Having said that, it's good to know that most of the damaged street/stop signs have been repaired and erected with new pressure treated 6x6s, steel plates, screws and compacted in the ground with stones.

JANUARY 2024 BEACH UPDATES: >Paul Yellen

This winter has been challenging when it comes to maintaining our beach. Early January brought in a severe storm that pushed beach sand over the top of the seawall at the end of Sea Spray and onto some front yards. Normally these storms don't arrive until mid to late winter and our resident beach expert, George Finley, says he has never seen conditions like this so early in the year.

The BOG was proactive in authorizing the engagement of a contractor to do preventative work to help mitigate future sand movement off the beach. A 6' high berm was created at the high tide mark at the end of Sea Spray and sand was pushed back along the beach toward Saltaire. These actions lowered the level of the sand at Sea Spray approximately 3'.

Another storm last weekend showed that the berm did not perform as well as expected when we witnessed the sand being pushed back over some portions of the seawall, and the water from the Sound at high tide being pushed over the seawall down onto Sea Spray and flowing to the lower part of Saltaire. There was yard flooding as far up as 59 Sea Spray. Several other beaches created berms as well and we have learned that they were not successful in keeping the water and sand from spreading off the beach.

Storms are an inevitable way of life here at the beach, with sand movement and flooding occurring despite mitigation actions that are taken. It is terrible to have storm damage affect one's property, but the Association cannot control or be responsible. We have consulted with and plan to have our contractor take additional mitigation steps which may involve the contractor pushing sand further down towards the water and pushing sand from the Sea Spray area of the beach towards the Billow area of the beach. We hope that nature cooperates so we will not even need to evaluate whether these steps did the job as intended.

After an almost three year "pause", the WPCA has been in active discussions with our partner beach communities, the Town of Old Lyme, and the State of Connecticut to secure the additional funding needed to make the sewer project financially viable.

Most recently, DEEP, the WPCA Board and the Board of Governors have agreed to extend the contracted project start date of March 31, 2024, an additional twelve to eighteen months to allow time to obtain updated construction bids and complete financial due diligence. There is an enormous amount of work ahead of us and the WPCA is committed to increasing its communication efforts this year to keep OLS residents fully informed on the project status. Attendance at the monthly WPCA meetings is encouraged. The next regular meeting is scheduled for February 20th, 2024, at 7pm via Zoom.
